Directions:

About one quarter mile off Bingham Road; at the intersection of I-70; on the south side of Bingham Road and north of I-70. This cemetery is located on the grounds of State School #53.

Atlas Survey:

1877 land atlas – a school symbol here, but no cemetery symbol on David Smith land

1915 land atlas – a school and cemetery symbol here on J. W. Cunningham land

1978 land atlas – a school but no cemetery symbol here on John Windsor land

1991 land atlas – no symbols here on Caroline Windsor land.

History:

"There was evidence of possibly 15 to 20 more graves here; but no data; only the flowers, called "Live and Never Died" an ever living flower that was usually planted on graves in early times. In the middle of the cemetery there are four iron pipes, set in the ground, about the size of a grave with an iron piece about the size of a coffee can on top of each pipe" - not identified."

This cemetery was recorded by Mrs. Caroline Wolfe and Mrs. W. H. Flanagan of Boonville, Missouri on 18 Nov. 1970. It also includes additions from old obituaries furnished by member of the family. The data on two burials are from Mrs. Jean Carter's book on "Cooper County Pioneers". Later entries include information from the Cooper County Record of Deaths.

From personal knowledge (2007), this school has been converted to a family residence.

Evans	George Lafayette; no dates; husband of Elizabeth Evans
Fowler	Not Named; born in Missouri; died 02 Jul 1888 in Clarks Fork Township, Cooper County, Missouri; aged 3 months, 6 days; buried 03 Jul 1888; CC Records of Death
Hurt	Clayton A., Col.; born 15 Jan 1790 in Bedford County, Virginia; died 13 Jun 1862; husband of Mary Ann "Polly" née Dillard Hurt
Hurt	James T. ; born 14 Feb 1855; died 03 Apr 1923; husband of Nancy Peyton née Davis Hurt; married 05 Dec 1865

Hurt	William, Sr.; "William Hurt, Sr., son of Col. Clayton Hurt and Mary Ann "Polly" née Dillard Hurt was married to Catherine Robertson (Sept. 6, 1837); a daughter of Capt. Andrew Robertson, on of the earliest settlers of Cooper County. Also, Edward and Charles Robertson (possibly brothers of Andrew) were among the earliest settlers of this area." From "History of Cooper County, Missouri" by Johnson, 1919. These person could possibly be in some of the above unmarked graves.
